

# CHN Group Camping Liability Release & Emergency Information Form

*We strive for a safe and enjoyable camping experience for all campers. With this in mind, we ask that all families read the following guidelines. If any of these group expectations are different from family rules at home or at other events, please discuss them with your children, perhaps with an explanation that sometimes for the well-being of a large and diverse group community, we temporarily do things differently than we might in our own home, in order to respect the needs of others.*

**SUPERVISION:** A responsible adult/teen should supervise children at all times while at the campout.

**QUIET HOURS:** Official park quiet hours are 10:00 pm-6:00 am. For everyone's comfort, because sleep schedules vary, please help your child choose quieter activities from 9-10pm and 6-7am.

**FIRE PIT:** Children should not play in or near fire pits. All cooking, including marshmallow roasting, should be supervised by an adult or teen, for the safety of the child as well as the other campers.

**BIKES, ETC:** Wear a helmet – it's state law. To avoid injuries to themselves and others, please do not allow your children to ride wheeled vehicles through the community living area after dark, and remind them to use caution on the tent-to-bathroom paths at all times.

**BATHROOMS:** Out of respect for the comfort and privacy of all campers, please do not allow your children to play in the bathrooms.

**SMOKING:** If the park permits smoking, please choose an area away from the group tent site, group meeting areas, main paths, and children's play areas.

**PETS:** If the park allows dogs, please set up your tent away from the main meeting and play area, for your dog's comfort as well as the safety of the children running by. Do not leave your dog unattended. If your pet exhibits unexpected aggressive or disruptive behavior, remove it from the group campsite.

*I certify that I am aware that certain risks are inherent in camping and related outdoor activities including hiking and campfires, and that I voluntarily assume all risks associated with my participation and the participation of my children, family members and guests in these activities. I agree to release and hold harmless California Homeschool Network, its trustees, officers, employees, agents, representatives and volunteers from any claims for personal injury or property damage arising out of or connected with my or any member of my party's participation in this event whether this injury or damage was caused by negligence or otherwise, and I hereby voluntarily waive my right, and the rights of my heirs or agents, to make a claim or sue for such injury or damage.*
